Carriage

All order to the NET value of £150 will be carriage paid (applicable to the Uk only). Orders less than £150 NET will be subject to a standard carriage charge, charges depend on Uk postal code.

Shortages, Damages & Faulty Goods

All shortages, damages or faulty goods must be reported within 24 hours of delivery/collection. Failure to comply will result in orders considered complete and accepted by the customer. All deliveries must be checked and signed for at time of delivery; signing carrier's delivery note "unchecked" or similar will not be acceptable.

Claims

In accordance with Transport Regulations, claims for loss, damage or shortage must be made in writing within five days of receipt of goods. Non-arrival of goods should be notified in writing within fourteen working days of invoice date.
